RESOLUTION IN NEED OF OFFER AND SUPPORT – Approving the application for American Fireworks to perform the Dearborn Homecoming Fireworks Displays on August 6th, 2022 through August 7th, 2022, and waiving all licensing and permitting fees subject to compliance with all conditions and requirements and requesting immediate effect.

RESOLUTION IN NEED OF OFFER AND SUPPORT – Authorizing the Mayor to execute the Parking Lot Use Agreement with Ghafari Associates, LLC, 17101 Michigan Ave., for the use of Ghafari's Parking lot for the Dearborn Homecoming Festival on August 5th, 2022 to August 7th, 2022 subject to the review and approval of Corporation Counsel and requesting immediate effect.
