2. To consider the request by the University of Michigan-Dearborn's Early Childhood Development Center's Parent Association for permission to post up to thirteen (13) yard signs on City property for the Mom-to-Mom fundraiser set for Saturday February 27th, and
3. To consider such other items of business that may properly come before the Council in relation to the above subject matters.

1-54-10. RESOLVED: That the public hearing to consider the confirmation of Special Assessment District Roll 869 for the purpose of repair and asphalt paving of Morross Circle be and is hereby terminated.

The resolution was adopted as follows: Yeas: Abraham, Darany, Hubbard, O'Donnell and Tafelski (5). Nays: None. Absent: Sareini and Shooshanian (2).

1-55-10. WHEREAS: Council Resolution No. 8-535-09 created Special Assessment District No. 869, and

WHEREAS: City Assessor had prepared proposed Special Assessment Roll No. 869 to allocate costs of \$114,510, as incurred by the City for the Repair and Asphalt Paving of Morross Circle Road together with the cost of preparing said roll, and

WHEREAS: The benefitting property owners' pro-rata cost, as prepared on the Special Assessment Roll 869 for the Repair and Asphalt Paving of Morross Circle Road amounts to \$2,245.29 per parcel, and

WHEREAS: Alternative to a single special assessment payment, it is recommended that the affected property owners be allowed to pay said special assessment over a seven (7) year period, at an interest rate of seven percent (7%), resulting in a level constant payment of principal and interest in the annual amount of \$416.62, and

WHEREAS: In compliance with Chapter 15 of the City Charter, the City Assessor has certified the proposed roll as having been made on a pro-rata basis according to the benefit to be derived by affected property owners, and

WHEREAS: Said Council Resolution No. 1-2-10 designated Thursday, January 28, 2010 at the Council Chambers, City Hall, City of Dearborn at 6:00 p.m. as the date and time for holding a public hearing to review the Special Assessment as identified in the proposed Special Assessment Roll No. 869, and a public hearing was held in accordance with the provisions of the City Charter, and

WHEREAS: The City Council received no written and no oral requests for modifications of proposed Special Assessment Roll No. 869 from affected parties, and

WHEREAS: The Special Assessment is the obligation with respect to all of the individual parcels of property within the Special Assessment District No. 869, and shall, until paid, be and continue to be a lien upon all such property assessed for the amount of the Special Assessment and all interest and charges apportioned to such property which may accrue thereon; be it

RESOLVED: That the City Council hereby confirms Special Assessment District Roll No. 869, as certified, attached hereto, for the Special Assessment levied for the Repair and Asphalt Paving of Morross Circle Road with allowable payments for a seven (7) year period; be it further

RESOLVED: That all Special Assessments contained in Special Assessment District Roll No. 869 shall be due and payable within thirty (30) days of billing by the Finance Department; seven percent (7%) interest shall be charged on all accounts not paid within thirty (30) days of billing date; be it further

RESOLVED: That to insure the timely implementation of the provisions of this resolution, it is hereby given immediate effect.
