WHEREAS: Mobile X is seeking City Council approval to hold a Chrysler dealership training program at Fairlane Town Center from Monday, April 11 through and including Friday, April 22, 2016 from approximately 7:00 A.M. to 5:00 P.M. April 11<sup>th</sup> through April 17<sup>th</sup> will be set up and rehearsal days with no participants and April 18<sup>th</sup> through April 22<sup>nd</sup> will have 300 participants per day divided into two 150 person sessions, and

WHEREAS: The Chrysler Pacifica Training Tour is part of a 25 city tour which will allow dealership employees the opportunity to drive vehicles on 2 low speed (5-15 mph) closed courses and to attend training modules focusing on sales strategies and new features of the latest Chrysler Minivan and its key competitors. The classrooms will be located inside five (5) various sized tents erected on approximately 100,000 square feet of the parking lot at Fairlane Town Center. (See Site Plans and Layouts), and

WHEREAS: The entire site will have Fire Department access. Display cars in the tents will have the batteries disconnected with the gas tanks drained and caps taped shut. The tents will have lighted exit signs, no smoking signs, fire extinguishers and first aid kits. The tents will be secured to water barrels and will be inspected by inspectors from the Property Maintenance and Development Services Department, and

WHEREAS: Mobile X is requesting City Council approval for the temporary use of land and temporary structures for this special event; therefore be it

RESOLVED: That Mobile X be and is hereby granted approval for the temporary use of land and temporary structures to hold a Chrysler dealership training program at Fairlane Town Center from Monday, April 11 through and including Friday, April 22, 2016 from approximately 7:00 A.M. to 5:00 P.M.
