10-477-19. WHEREAS: Council Resolution No. 12-597-14 created Special Assessment District No. 871 and

WHEREAS: City Assessor has prepared proposed Special Assessment Roll No. 871 for distributing costs of maintaining city-owned public parking lots and related area in the West Dearborn Business District for a one-year period; and

WHEREAS: The cost of maintenance of city-owned public parking lots in the West Dearborn Business District is \$ 202,547.42 for July 1, 2017 - June 30, 2018; and

WHEREAS: In compliance with Chapter 15 of the City Charter, the City Assessor has certified the proposed roll as having been made on a pro-rata basis according to the benefit derived by affected property owners; and

WHEREAS: Said Council Resolution No. 9-398-19 designated Thursday, October 17, 2019 at the Council Chambers of the Dearborn Administrative Center, City of Dearborn at 6:30 p.m. as the date and time for holding a public hearing to review Special Assessments as identified in the proposed Special Assessment Roll No. 871 and a public hearing was held in accordance with the provisions of the City Charter; and

WHEREAS: The City Council received zero (0) written and oral requests for modifications of proposed Special Assessment Roll No. 871 from affected parties; therefore be it

RESOLVED: That the City Council hereby confirms Special Assessment Roll No. 871, as amended, attached here to, for the special assessments levied for the maintenance of the city-owned public parking lots and related area in the West Dearborn Business District; be it further

RESOLVED: That all Special Assessments contained in Roll No. 871 shall be due and payable within thirty (30) days of billing by the Department of Finance; one percent (1%) per month shall be charged on all accounts not paid within thirty (30) days of billing date, be it further

RESOLVED: That delinquent balances as of December 31st will be charged an additional 25% and will be transferred to the tax roll, be it further;
